Please note that vendor spaces are available on a first come first serve basis and are not available to all applicants. No Direct Market Sales, hand made goods only. Vendors must have 2 of the following platforms they sell their items from to participate and have clients reach out to. (website, FB, IG or ETSY)

Approved vendors will receive an invoice after application is received for payment process.

Payments can be made via e-transfer, cash or cheque one month prior to event, to secure space. No spaces are held unless payment is received.

Any cheques returned by your bank will cause your acceptance to be null and void. Please see rules and requests.

RULES AND REGULATIONS

1. Participants must supply their own display items, power cords, shade tents, cash box, generators, float, pens, equipment, and supplies required for the duration of the event. Vendors are responsible for their own equipment and assume all risk and liability in the event of loss or damage. Please mark your equipment with your name.
2. Participants are responsible for keeping their area clean during and after the event. Garbage cans will be provided.
3. All participants must be completely set up by 9:45 am on each Saturday.
4. Sale permits, licenses, and collection of all appropriate sales taxes and HST are the sole responsibility of the participant. You are responsible for your own charge card services.
5. Booth space is for single operation only. No subleasing or sharing of space is allowed unless specified in writing.
6. Vendors may not sell any drug paraphernalia, tobacco products, weapons or illegal studded jewelry.
7. All sales are from the vendor's assigned booth only. No roaming sales.
8. No bullhorns or megaphones, flashing lights or strobes, speakers or sound amplification.
9. No hawkers. Vendors may not solicit or harass the crowd for sales.
10. Participants are expected to participate for the duration of the event, unless notice and approval are granted prior to the event.
11. No profanity or abusive behaviour is permitted. Violation of this policy will result in your removal from the premises, and the event, and your participation in future events will be thoroughly evaluated. No refund will be issued.
12. Vendors agree to grant GARDEN PARTY MARKET the right to use and publish any photographs taken at GARDEN PARTY MARKET of their exhibit and/or vendor staff for editorial, trade, advertising, and any other purpose.
13. Alcohol is not to be purchased and consumed by a vendor on site. Alcohol and/or narcotics are prohibited from GARDEN PARTY MARKET grounds. If a vendor or their designee is caught in violation of this regulation the booth will be shut down immediately and not allowed to re-open until a designee from the GARDEN PARTY MARKET deems it acceptable. If the booth is shutdown for the duration of the market no refund or reimbursement will be given.
14. Vendor spaces are limited and will be reserved on first come, first serve basis.

15. Vendor space will be considered reserved when full payment has been received. Payments must be made in full 1 month prior to first event if paying for the season (April 11th 2021), and 1 month prior to each event if paying per date.
16. Cancellations must be received in writing. There will be no refunds issued and vendors will be responsible for the full amount of all vendor fees as we may not have time to replace the space.
17. Vendors are responsible for their own insurance. The GARDEN PARTY MARKET or The Planted Arrow Flowers & Gifts are not responsible and/or liable for any claim by a third party made on the vendors for their fault or deemed negligence.
18. Parking is the sole responsibility of the vendor. Load in/out access will be allowed for a short period of time for the delivering and restocking of food, merchandise and/or other supplies only. Vendor parking will be assigned on site at each event.
19. Dress and attire should be appropriate for a family event and environment.
20. Any cheques returned by your bank will result in a \$25 NSF fee.
21. Exhibitors are expected to participate for the duration of the event, rain or shine. All Vendors fees are non-refundable, unless extreme weather conditions force the GARDEN PARTY MARKET planning committee to declare the event cancelled. Failure to comply with the above will result in the expulsion from GARDEN PARTY MARKET 2020. The GARDEN PARTY MARKET will not be responsible for any expenses associated with the closing of the booth.
22. With current circumstances of COVID 19 we do have all regulations and policy's required to proceed with safety and vendors will be required to comply. Details will be provided at time of application approval.
